Main duties and responsibilities
<ul style="list-style-type: none"> • To provide a high standard podiatry service, being responsible for the treatments' outcome and ensuring a satisfactory experience and service to the patient. • To perform a wide range of podiatry treatments including but not limited to biomechanics, Swift Microwave Therapy, Nail Surgery, Diabetic Assessment and foot healthcare, Corns, Callus, and nail care. • To keep accurate electronic records of treatment and advice given on Cliniko. • To keep the work-station clean, tidy, and stocked with the relevant tools/supplies. • To regularly inspect equipment and report any defects or problems. • All used equipment to be removed from the treatment room after each patient and sterilized. • Cleaning of treatment room between each patient and to assist with the end of day cleaning of the clinic. • To promote the full range of products within the clinic, share with patients to improve sales. • To deal effectively with complaints, ensuring that these are dealt with accordingly to the procedures and escalated when necessary. • To work as part of a team to implement new procedures and protocols regarding health, safety, hygiene, clinical standards, and treatment protocols across the clinic, proposing and recommending improvements in all areas of the podiatry clinic. • To assist and attend training sessions when asked and to identify development needs to promote continuous development of company staff. • Act as an ambassador and undertake representation duties as required on behalf of the company to events, press, clients, and other bodies. <p>The above is not an exhaustive list of duties, and you will be expected to perform different tasks as necessitated by your changing role within the organisation and the overall objectives.
